### Item 5a. Executive Director Report

Mr. Doane Liu provided an overview of his activities since the last Board meeting, which included: participating in site visits with Project Management Institute as well as the Nagoya City Assembly, a meet and greet with GeoTab held at the AC Moxy, a reception with UN Ambassador Linda Thomas Greenfield, the Global Sustainable Tourism Council regarding destination assessment, the LATCB Summer Board meeting, and led the Siggraph Pre-Con Roll Call.

# Item 5b. ASM Monthly Update

Ms. Kimberly Weedmark reported on 6 local events during June 2023, with 42,400 total number of attendees and one filming/parking clients, as well as the Sales and Marketing activities, noting the soft month due to the cancellation of E3. Mr. Zarhoud presented the financial data for June, reporting an operating loss of \$1.3M and \$2.8 in gross revenue, which was \$1.9M below prior year and the pre-COVID two year average. Mr. Zarhoud also reported \$2.1M in operating expenses. Mr. Zarhoud reported June's exhibit hall occupancy was 45% driven by a large volleyball event booked short term as a result of the E3 cancellation. Mr. Zarhoud stated that the LACC May Economic Impact was \$6.4M, all from short term business.

# Item 5c. LATCB Monthly Update

Mr. Darren Green reported that LATCB has processed 96 leads year-to-date and booked 67,783 room nights with a goal of 140 leads and 275,000 room nights, noting that while leads are behind pace they expect to make up the difference and room night are ahead of pace even with a cancellation in 2026. Mr. Green reported on the impact factors for FY 2022-23, data points and trends, the FY 2023-24 Sales Strategies, the Sales and Services Support Initiatives and the awareness plan of key vertical market segments. Mr. Green also provided an overview of Cvent, the leading provider of hotel and venue leads for potential meetings and events, noting that LATCB responded to 92% of the leads supplied.
